

## 2025 ADAP Data Report (ADR) Validations

#### Notes:

- Client Level Data Validations Messages
  - Validation Check #94 has been disabled.
  - Validation Check #109 logic and language updated. The logic and language were updated to incorporate the reporting change to insurance assistance type (a new response option of “Full or Partial Premium Payment” replacing two separate response options: (1) Full Premium Payment; and (2) “Partial Premium Payment”).
  - Validation Check #110 logic updated. The logic was updated to incorporate the reporting change to insurance assistance type while the validation message remains the same.
  - Validation Check #115 downgraded to an “Alert”.
- Any ‘Note’ mentioned within the validation messages is not displayed on the screen for the user. It is purely for user reference within this document.

Validations are highlighted in yellow if they were added, the level was changed (been promoted from “alert” to a “warning”, or from “warning” to an “error”, or downgraded from “error” to a “warning”), or the conditions that trigger the validation were revised.
